8. When I asked him about the whereabouts of the sound systems, he replied to me saying that due to the ongoing violence in Manipur none of the sound systems appliances and equipment could not be brought back from Arunachal Pradesh. He also further informed me that some of the sound systems such as Speakers, Line Array Speakers and Sub-Speakers were not working properly, so he told me that he had kept them in Arunachal Pradesh

9. Yesterday, I came to learn that the said Ramngachan Kazingmei Shimrei had sold away all the sound systems, which were brought in by him by using the sum of my share of investment. He had cheated me by his illegal act of him selling away all the sound systems by keeping me in dark. In this illegal act, he has done mischief causing immense lose and damage of lakhs of rupees to me. He has committed criminal breach of trust. He has also committed cheating and dishonesty inducing delivery of property.

10. Therefore, I request you to immediately register a case against the said Ramngachan Kazingmei Shimrei under Section 316 (2) Criminal breach of trust, Section 318 (4) [Cheating and dishonestly inducing delivery property], Section 324(5) [Mischief causing loss or damage to the amount of one lakh rupees or upwards], which are all cognizable criminal offences under B.N.S., and other relevant provisions of B.N.S. as per law.

- 6. In 2023 February, the said Ramngachan Kazingmei Shimrel came to the registered office of the private company in Imphal Fast to take away all the sound systems by informing me that he would be needing them in rock concerts. In the first week of May 2023, the said Ramngachan Kazingmei Shimrel informed me that he would be going to Arunachal Pradesh for providing sound systems for multiple shows in Arunachal Pradesh.
