


Subject: Report.

On further verification, the detainee stated that he is an active member of the outfit KCP (Apunba) group joined through one Mr. Chalamba of KCP (Apunba) group in the month of August, 2023. The detainee further stated that, he got his basic military training under the command of one Mr. Robert of KCP (Apunba) group and presently working under the command of the said Mr. Chalamba of KCP (Apunba). So, the detainee was arrested from the backyard of his residence i.e. Kongpal Chingangbam Leikai, Imphal East District at 10:35 a.m. by observing due formalities. The arrested person is being handed over to you for further legal procedures against him.
