I have the honour to state that today i.e. 13/07/2025 at about 03:40 pm, a reliable information was received regarding the presence of some active cadres of KCP(MFL) organization (a faction of KCP organization) in and around Wangkhei and Palace Compound area of Imphal East District with a view to commit prejudicial activities like extortion of money from shops and general public etc. Based on the information, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri. P. Achouba Meetei, MPS, Dy.SP(CDO)IW and under the supervision of Shri. Gaurav Dogra, IPS. i/c Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS. SP-IW rushed to the said area after giving prior information to Imphal East Police Control Room and conducted search operation at Palace Compound area. During that one suspected person was detained at Palace Compound near the Eastern gate of Hapta Kangjeibung, Imphal East District. On spot verification, the detainee identified himself as Athokpam Sunil Langamba (43 yrs.) @ Lelin s/o (L) A. Manimatum Singh of Wangkhei Ningthem Pukhri Mapal, Imphal East District.

During preliminary verification, he disclosed that he is an active member of KCP(MFL) organization (a faction of KCP organization) and joined the KCP organization in the year 2003 through one Noyon @ Laba, the then s/s General Secretary of KCP organization. He also disclosed that he is presently working under the command of one s/s Deputy Finance Bobby Thongam (Ph. No. 8414851166) of KCP(MFL) organization who is presently staying in Myanmar. He further disclosed that under the instruction of his commander Bobby Thongam, he was involved in collection of extortion money from Petal nut Dealers and Fish Dealers in valley areas since April, 2024 and had collected around Rs. 50,00,000/- from the above mentioned dealers as their party fund and handed over the extorted money to some unknown persons sent by his commander. Further, he disclosed that he is also presently working under the command of one s/s Chief of Army Ibomcha @ Kriti (Ph. No. 8798928427) of KCP(MFL) organization who is presently staying in Myanmar.

Hence, he was arrested from the spot i.e., at Palace Compound near the Eastern gate of Hapta Kangjeibung, Imphal East District at 04:15 pm by observing necessary formalities.

From his possession, (i) one Redmi 13 5G mobile handset along with one Airtel SIM card bearing mobile no. 8732844375 (as disclosed by him), (ii) one Redmi Note 14 5G mobile handset along with one Jio SIM card bearing mobile no. 7005763409 (as disclosed by him) and (iii) one Redmi Note 8 Pro mobile handset along with one Jio SIM card bearing mobile no. 9366092537 (as disclosed by him) were seized at 04:24 pm by observing due formalities.

Hence, the arrested person and the seized articles are handed over to you for taking further necessary legal action against him.
