We have searched the school premises thoroughly and found signs of forced entry e school. Also found that they broke some locks and doors. It may kindly be noted that some civil works like viz Construction of CWSN toilets, repairing of floors, etc are undergoing at present in the school. As such, there were some openings of the compound walls. We have no information about the identity of the thieves yet, but we request you to kindly register this FIR and investigate the matter to recover the stolen goods and take action against the culprits.
