I have the honour to report that today i.e. the 28th July, 2025 at about 8:00 p.m. based on a credible information from our own source a combined team of CDO Imphal-East Unit and 4 AR conducted a C. I. Ops. at Haokip Veng along Mahabli area of Imphal East District under the command of Inspt. N. Devdas Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops)IE at about 9:00 p.m.

In that, one suspicious unknown person was detained for spot verification at Haokip Veng, Mahabali River Bank Imphal East District. On checking the detainee body, one AADHAR card was found and recovered from his Possession. On verification, the detainee identified himself as **Thiyam Boinao Singh** (17 years) S/o Th. Chaoba Singh of Yumnam Huidrom Makha Leikai, Imphal West District. On further verification, the detainee stated that he is an active member of the outfit KCP (PWG) joined the said outfit through one Sapam Muhindro Singh of KCP (PWG) in 8month of July, 2023 and presently working under the command of one Mr. Awangba of KCP (PWG).

So, the detainee was arrested from the spot i.e. Haokip Veng, Mahabali River Bank Imphal East District at 9:59 p.m. and seized one ADHAR card from his possession at about 10:05 p.m. by observing due formalities.

Therefore, the arrested person along with the seized item is being handed over to you for taking up further necessary legal actions against him.




