I have the honour to report that today i.e. the 31st July, 2025 at about 4:30 p.m. receive redible information from our own source about the presence of some active members of the or PREPAK (Pro) at Khurai area of Imphal East District. Based on the said information, teams CDO/IE Unit under the command of Inspt. N. Devdas Singh, OC-CDO/IE Unit and under supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops)IE conducted a searched operation at KI Chairen Thong, Imphal East at about 5:30 p.m.

In that, one unknown suspicious person was detained for spot verification and checking Chairen Thong near N.G. Mani College, Imphal East District. On checking the detainee body, mobile phone was found and recovered from his possession. On verification, the detainee iden himself as one Telem Naoba Singh @ Teba (29 years) S/o T. Sanjit Singh of Lairikyens Leikai Salan Leirak, Imphal East District. On further verification, the detained stated that active member of the outfit PREPAK (Pro) group, joined through one Mr. Guli of PREPAK (P month of January, 2024 and presently working under the command of one s/s - Captain Mr. Sa PREPAK (Pro). The detainee further stated that, he had extorted a huge amount of money from v private hospitals and clinics located at Imphal area under the command of the said Mr. Sa PREPAK (Pro) for raising their party fund.

So, the detainee was arrested from the spot i.e. Khurai Chairen Thong near N.G. Mani C Imphal East District at 6:14 p.m. and seized one mobile phone (Vivo Y12s) bearing IM 867600059984996 & 867600059984988 along with one JIO SIM card having phone No. 7005 from his possession by observing due formalities at the spot i.e. Khurai Chairen Thong near N.C College, Imphal East District at 6:20 p.m. by observing due formalities.

Therefore, the arrested person along with the seized mobile phone is being handed over for taking up further necessary legal actions against him.
