Sir,

I have the honour to state that today i.e. 01/08/2025, a reliable information was received from our own source and further corroborated from the information input provided by 33 AR regarding the presence of some active members of KCP organization, an outlawed banned organization in and around New Checkon area of Imphal East District with a view to commit prejudicial activities like extortion of money from shops and general public etc. Based on the information, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri. P. Achouba Meetei, MPS, Dy.SP(CDO)IW and under the supervision of Shri. Gaurav Dogra, IPS, i/c Addl. SP(Ops.)IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Police Control Room and conducted search operation at some suspected places of New Checkon area. During that one suspected person was detained at the construction site of New Checkon Tribal Colony, Imphal East District. On spot verification, the detainee identified himself as Yumkhaibam Ronaldo Meitei (24 yrs.) s/o Y. Shyamjai Meitei of Khurai Ningthoubung Leikai, Imphal East District.

During preliminary verification, he disclosed that he is an active member of KCP(MFL) organization (a faction of KCP organization) and joined the said organization in March, 2024 through one Sanajaoba of KCP(MFL) organization from his locality. He further disclosed that on 18/03/2025, under the instruction of one s/s Commander Hidam Aboy @ Atappa (Ph. No. 7085558884) of KCP(MFL) organization from Nongren, he and his associate namely Sanajaoba (the above mentioned) were involved in the firing incident at the house of a Forest Officer located at Uripok Achom Leikai, Imphal West District by using a Honda Activa scooter which was brought by his associate Sanajaoba, which refers to FIR No. 81(03)2025 IPS u/s 109/351(2) BNS, 20 UA(P) Act & 25 (1-B) Arms Act dated 18/03/2025.

Hence, he was arrested from the spot i.e., at the construction site of New Checkon Tribal Colony, Imphal East District at 12:15 pm by observing necessary formalities.

From his possession, (i) one POCO C51 mobile handset along with one Airtel SIM card bearing mobile no. 8132880621 (as disclosed by him) and (ii) one Aadhaar card bearing no. 5445 9982 0449 were seized at 12:22 pm by observing due formalities.

Hence, the arrested person and the seized articles are handed over to you for taking further necessary legal action against him.
