On 07/08/2025 at around 1600 hrs, on telephonic information about four personnel came to shopkeepers of Telipati, Imphal East that they demand from the said shopkeeper of Telipati localities for Rs. 4000.00 (Four thousand) as extortion money, received from No. 913202326 SI GD Siddalingaiah of B/66 BN CRPF, who is deployed at Hanuman Mandir, Telipati, Imphal East for Security Duty, I the undersigned ( INSP GD Ramendu Dixit) reached immediately at the spot with coy QAT and on seen our troops, all four personnel tried to fled away but our party managed to catch all four personnel with two Scooty bearing Regn No.- i) MN 06 S E 4230 & ii) MN 01 A C 9735 .They are detained for further verification and it is known that they made illegal demands for money . On enquiring it is also revealed that below mentioned personnel also taken extortion money (RS.-3000.00 to 4000.00) from other local public from Telipati, Imphal East.
