Sir,

I have the honour to report that today i.e. the 10<sup>th</sup> August, 2025 at about 4:30 p.m. based on a credible information from our own intelligence about the presence of some active members of the outfit KCP (Noyon) at Khurai area of Imphal East District. Based on the said information, teams of CDO/IE Unit under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops) Imphal-East rushed to the said area and conducted a random frisking and checking to the suspected passersby.

In that, one suspected person was detained for checking and verification. On checking the detainee body, two nos. of mobile phones were found and recovered. On verification, the detainee identified himself as one **Huidrom Sunder Singh @ Sanathoi @ Salai (39 years) S/o H. Shamu Singh of Sekta Awang Leikai, Lamlai PS, Imphal East District A/p - New-Checkon Tribal Market, Imphal-East**. On further verification, the detainee stated that he is an active member of the outfit KCP (Noyon) joined through one Mr. Bobby @ Pamel of KCP (Noyon) in the month of August, 2023 and presently working under his command. The detainee further stated that, recently he made a monetary demand at a shop located at Khabeisoi, Imphal East for raising their party fund.

So, the detainee was arrested from the spot i.e. Khurai Chaithabi Leirak, near SHAIBO Hospital at 5: 56 p.m. and seized; (i) **One mobile phone( Redmi note13 pro) bearing IMEI NO. 864698062156100 & 864698062156118 along with two Airtel SIM cards having nos. 8974427027 & 7629032191 and (ii) One mobile phone(NOKIA TA- 1423) bearing IMEI NO. 353015618597216 along with one Airtel SIM card having no. 8131967631** from his possession at the spot i.e. Khurai Chaithabi Leirak, near SHAIBO Hospital at 6: 05 p.m. by observing due formalities.

Therefore, the arrested person along with the seized mobile phones are being handed over to you for taking up further necessary legal actions against him.
