I have the honour to report that today i.e. the 14<sup>th</sup> August, 2025 at about 6:20 p.m. received a credible information from our own source and with the intelligence of 165 TA about the presence of an active member of the outfit PREPAK at Soibam Leikai, Imphal East District. Based on the said information, a combined team of CDO/IE Unit, ex column of 165 TA and 4 AR under the command of Shri. Khumanthem Dhiraj Karan, MPS, Dy. SP(Ops)IE also looking after the charge of OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops)IE rushed to the said area and conducted a random frisking and to the suspected passersby at about 7:10.m.

In that, one unknown suspicious person was detained for spot verification at Soibam Leikai near Citizen Club, Imphal-East District. On verification, the detainee identified himself as one **Chabungbam Kenedy Singh @ Chingshuba (21 years) S/o (Late) Ch. Joy Singh of Chingmeirong Maning Leikai, Imphal West District.** On further verification, the detainee stated that he is an active member of the outfit PREPAK (Pro) joined the outfit through one s/s - Corporal Mr. Maimu of PREPAK (Pro) in the month of January, 2024 and got his basic military training for fifteen days under the command of one Mr. Punshiba of PREPAK (Pro). The detainee further stated that he is presently working under the command of one s/s - Mr. Yaima of PREPAK (Pro).

So, the detainee was arrested from the spot i.e. Soibam Leikai near Citizen Club, Imphal East 7:50 p.m. by observing due formalities.

Therefore, the arrested person is being handed over to you for taking up further necessary legal actions against him.

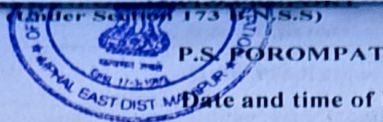
