Sir,

I have the honour to state that today i.e. 19/08/2025 at around 11:20 am, a reliable information was received from our own source and further corroborated from the information input provided by 4 AR regarding the presence of some active cadres of KCP organization, an outlawed banned organization in and around Wangkhei area of Imphal East District with a view to commit prejudicial activities like extortion of money from shops and general public etc. Based on the information, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri. P. Achouba Meetei, MPS, Dy.SP(CDO)IW and under the supervision of Shri. Gaurav Dogra, IPS, i/c Addl. SP(Ops.)IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Police Control Room and conducted search operation at Wangkhei Angom Leikai area. During that one suspected person was detained at a house located at Wangkhei Angom Leikai. During spot verification, the detainee identified himself as Lourembam Suraj Singh (26 yrs) @ Lamjingba S/o. (L) L. Amu Singh of Wangkhei Angom Leikai, Imphal East District (who later identified himself as the resident of the said house).

During preliminary verification, he disclosed that he is an active cadre of KCP(MFL) organization (a faction of KCP organization) and joined the said organization in the year 2017 and got Basic Military Training for 45 days in Tamu, Myanmar and was allotted Army no. 530 and is presently holding the rank of s/s Corporal of KCP(MFL) organization. He also disclosed that he is presently working under the commands of (i) one s/s Commander Bobby @ Pamel (Ph. No. 6909223073) (Finance) of KCP(MFL) organization who is presently staying in Myanmar and (ii) one s/s Commander Lamngakpa (Ph. No. 9233637357) of KCP(MFL) organization who is also presently staying in Myanmar. On further verification, he disclosed that under the instruction of his Commanders, he and his associate namely one Tondonba from Napat were involved in extortion activities by serving monetary demands/threats to general public in valley area.

Hence, he was arrested at the spot i.e., from his residence at 12:35 pm by observing necessary formalities.

From his possession, (i) one realme 14x 5G mobile handset along with two SIM cards i.e., (a) one Airtel SIM card bearing mobile no. 8974260038 (as disclosed by him) and (b) one BSNL SIM card bearing mobile no. 9436414885 (as disclosed by him) and (ii) one Aadhaar card bearing no. 8363 4868 0400 were seized at the spot at 12:42 pm by observing due formalities.

Hence, the arrested person and the seized articles are handed over to you for taking further necessary legal action against him.
