From his possession, (i) one OPPO A9 2020 mobile handset along with one Jio SIM card hearing mobile number 6009839063 (as disclosed by him), (ii) one demand letter of "KANGLEIPAK COMMUNIST PARTY MPARTMENT OF FINANCE" bearing Ref. No.: 504/Fin/KCP/25/01 signed by Th. Bobby Deputy Finance Secretary Americanak Communist Party dated 07/07/2025 and (iii) one Aadhaar card bearing number 9796 2592 0667 were recovered.

During preliminary verification, he disclosed that he is an active member of KCP(MFL) organization (a faction of NCP organization) and started working for the said organization since April. 2024 through one ses Commander Panthoi of KCP(MFL) organization from Thoubal side. He also disclosed that he is presently working under the command of the above mentioned Commander Panthoi (Ph. No. 8131043963 and 8258086009) who is also working as s/s Publicity Secretary of KCP(MFL) organization and presently staying in Myanmar. On further verification, he disclosed that under the instruction of his commander, he was involved in extortion activities by serving monetary demands/threats and collecting money from schools, government officials and general public in valley area and the extorted money were handed over to his commander through some unknown persons sent by his commander as their party fund.

On thorough verification, he disclosed that he was also involved in sending extorted money (around Rs. 1,05,500/- in total) through Google Pay to the following mobile nos. (i) 8415916938 (Ding Ding), (ii) 9233126464 (Vikash Khanal), (iii) \$131829706 (Nengnulhungdim Lhungdim) and (iv) 8287541850 (Anil Verma) which were provided by his commander Panthoi for their party fund.

On checking his mobile handset (above recovered), some incriminating documents like demand letters were also found which will be served, after printing out, to general public for extortion activities.

Hence, he was arrested at the spot i.e., from his residence at 07:20 pm and the above recovered articles were seized at the spot at 07:29 pm by observing necessary formalities.

Hence, the arrested person and the seized articles are handed over to you for taking further necessary legal action against him.
