

**Subject:** Complaint against mob attack led by one Maibam Rabon alias Sherjit of Wangkhei Keithel Asangsabi Leirak under Porompat PS, Imphal East district and others and also protects us from ousting the locality.

I, the undersigned have the honour to state that the following few lines are before you for your kind perusal and prompt action:

That on 22<sup>nd</sup> August 2025 at around 10.30 am, I was severely beaten by a mob led by Maibam Rabon alias Sherjit Singh son of M. Kullachandra and his team over a land dispute that is currently pending in a competent court inside the gate of my house. The mob attack resulted in injuries to my face and accordingly I received treatment at JNIMS hospital. Moreover all the members of my family have also been in trauma status because of the attack. Further, on the same day at around 8.00 pm, two members of my family i.e Maibam (O) Keilani Devi and Maibam Ranika Devi were forcibly called out and took them at the Keithel Ashangbi Community hall and there they were threatened to surrender me immediately before the mobs being gathered at the community hall otherwise dreadful consequences may be faced. Subsequently the mobs decided to expel my family from the locality and all the family members should leave the locality within 4 (four) days from 22<sup>nd</sup> August, 2025.

In this matter, you are kindly requested to take immediate action by registering against Rabon and other individuals involved in the mob attack. I also request you that appropriate legal action be taken against them according to the law. I have attached a copy of the medical document of my injuries issued from JNIMS hospital.

The details of culprits are as under:

- Maibam Rabon alias Sherjit (43) S/O M. Kullachandra of Wangkhei Keithel Asangsabi Leirak under Porompat PS, Imphal East and his followers.
- Some young Maira paibis(women torch bearer).

I, therefore, request you kindly to investigate the matter; register an FIR and take up necessary legal action against the accused persons for the end of justice.

Kullachandra of Wangkhei Keithel Ashangbi Leirak, I/E and some young Meira paibis(women torch bearer) had physically assaulted him (complainant) over a land dispute and also threatned him Wangkhei Keithel Ashangbi. Further, on the same day two members of his family i.e, Maibam (o) Keilani Devi and Maibam Ranika Devi were forcibly called out and threatened by the abovementioned accused person. As a result of which, he susntained injury on his body and treated at JNIMS, Porompat. Hence the case.
