I have the honour to report that on the 16th September 2025 at around 8.00 pm while my daughter namely Irungbam Bidyarani 19 yrs was driving her two wheeler Honda Activa MN06SF -8069 along with her sister namely Irungbam Lakshmi 22 yrs in the road of Wangkhei Puja Lampak from north to south direction. one unknown driver of a four wheeler vehicle Tata Nexon white in colour bearing regd. number not known driving from south to north had hit on the right front part of her vehicle due to rash and negligent driving on the part of unknown driver of Tata Nexon. But the unknown driver had fled away from the spot without stoping the vehicle after hitting. Because of the impact my two daughter, the driver and the pillon rider of the Honda Activa sustained serious injuries on their persons and evacuated to the Advanced hospital for treatment. And also the right front side of the Honda Actiba got badly damaged.

It is therefore, requested to kindly take up necessary action against the unknown driver of the four wheeler vehicle as per the law of the land.
