Sir,

I have the honour to report that today i.e., the 27th September, 2025 at about 2:00 p.m. received a reliable information from 33 AR corroborated with our own source about the presence of an active member of the outfit RPF/PLA at Khurai Lamlong and its surrounding area of Imphal-East District. Based on the said information and with the permission/authorization of the authority, teams of CDO/IE Unit conducted a C.I. Ops. at the said area under the command of Shri. Khumanthem Dhiraj Karan, MPS, Dy. SP(Ops)IE also looking after the charge of OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops)IE at 2:40 p.m.

In that, one unknown suspicious person was detained for spot verification and checking at Khurai Konsam Leikai, Imphal East District. On checking the detainee body, one mobile phone and one wallet were found and recovered from his possession. On spot verification, the detainee identified himself as one; **Moirangthem Chaobi Singh @ Yaima (53) S/o (I.) M. Mani Singh of Heirok Part II Laishram Leikai, Heirok Police Station, Thoubai District, A/p - Heirok Part - III Kavo Leikai, Heirok PS, Thoubai District**. On further verification, the detainee stated that he is an active member of the outfit RPF/PLA joined in the year 1997 and got his basic military training in the same year under the command of one Mr. Kunjo of RPF/PLA. The detainee further stated that he is presently working under the command of one Mr. Subash of RPF/PLA and involved in the extortion of money to further party interest and also instigation and provocation of mob against security forces.

So, the detainee was arrested from the spot i.e., Khurai Konsam Leikai near Khurai Popular High School, Imphal East District at 3:17 p.m. and seized; (i) **One mobile phone (Redmi 12) bearing IMEI no. 865267061316310/78 & 865267061316328/78 along with one Airtel SIM card having phone no. 8132904311 and one wallet containing a sum of Rs. 220/- (two hundred twenty rupees) and one AADHAR card** from his possession at the spot i.e. Khurai Konsam Leikai near Khurai Popular High School, Imphal East District at 3:20 p.m. by observing due formalities.

Therefore, the arrested person along with the seized items are being handed over to you for taking up further necessary legal actions against him.
