I have the honour to report that on 04/10/2025 at around 03:00 pm, acting on reliable information received from Inspector Md. Rajib Khan, In-Charge, Cyber Lab, Imphal East District, regarding extortion activities in and around Porompat area, a combined operation was launched. A combined team comprising Cyber Lab personnel, assisted by a CDO/IE team, conducted the operation under the command of Kh. Dhiraj Karan, MPS, DSP (Ops), in charge of CDO/IE, and supervision of AK Sadananda Singh, Addl. SP (TCP/IE)overall in-charge Cyber Lab IE Dist. and Y. Joyraj Singh, Addl. SP (Ops/IE).At about 04:15 pm, the combined team detained one individual near the Water Supply of Porompat, Imphal East. The person was Malemnganba dentified Soibam 5/o Soibam Yaima Meitei of Yumnam Patlou Mayai Leikai, Sagolmang, Imphal East District. During examination, Soibam Malemnganba Meitei disclosed that he had been involved in extortion activities targeting the general public and government officials, acting under the command of Lenin @ Baji-mach of KCP (PWG). He further revealed that, he joined the said organization under one Lenin @ Baji-mach of KCP (PWG). The extorted amounts were reportedly transferred through GPay mobile number 7630843231, registered in the name of Mayengbam Netajit Singh, S/o Mayengbam Tombi Singh of Mayai Leikai, Uchiwa. He also stated that he was working in coordination with another cadre identified as Arshni of Yumnam Khunou Sanjenbam, Imphal East.Furthermore, the individual admitted that he is currently employed as a Chowkidar at Yumnam Patlou Primary School, Imphal East, and that he had previously been arrested thrice for his association with the said underground outfit. Accordingly, Soibam Malemnganba Meitei was placed under arrest at 04:26 pm from the spot i.e, near the Water Supply of Porompat, Imphal East. Further, two mobile handsets were seized from his possession at 5:28 pm at the Office of Cyber Lab,IE in the presence of witnesses, one mobile phone bearing phone no. 6909943433, IMEI 1-354821339122427, IMEI 2-354821339122435, and another damaged mobile phone, yellow and blue in colour.

The arrestee, along with the seized items, is hereby handed over to your kind authority for taking up necessary action as per law.
