## 12. First Information Contents:

Subject: - Report.

Sir,

I have the honour to state that today i.e. 13/10/2025 at about 01:35 pm, a reliable information was received from our own source and further corroborated from the information input provided by 33 AR regarding the presence of some active cadres of KCP(PWG) organization (a faction of KCP organization), an outlawed banned organization, in and around Top Makha Leikai area of Imphal East District with a view to commit prejudicial activities like extortion of money from the shops and general public etc. Based on the information and with the permission of the authority, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri. P. Achouba Meetei, MPS, Dy.SP(CDO)IW and under the supervision of Shri. Gaurav Dogra, IPS, Addl. SP(Ops.)IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Police Control Room and conducted search operation at Top Makha Leikai area. During that one suspected person was detained at a house located at Top Makha Leikai. During spot verification, the detainee identified himself as Wangkheirakpam Romeo Meitei (45 yrs.) @ Baruni @ Koubru S/o. (L) W. Momocha Meitei of Top Makha Leikai near Shagolssem Pukhri, Imphal East District, Manipur (who later identified himself as the resident of the said house).

During preliminary verification, he disclosed that he is an active member of KCP(PWG) organization (a faction of KCP organization) and started working for the said organization since August, 2025 through one Chandrakumar of KCP(PWG) organization from Ningthoukhong area. He also disclosed that he is presently working under the command of the above mentioned s/s Commander Chandrakumar (Ph. No. 9485288561) of KCP(PWG) organization. He further disclosed that under the instruction of his commander Chandrakumar, he was involved in extortion activities by serving monetary demands/threats and collecting money from brick fields and general public in valley area and the extorted money were handed over to his commander as their party fund.

Hence, he was arrested from the spot i.e., from his residence at 03:00 pm by observing formalities.

Further, from his possession, one Jio keypad mobile handset along with one Jio SIM card bearing mobile no. 9863379106 (as disclosed by him) and was seized at the spot at 03:06 pm by observing due formalities.

Hence, the arrested person and the seized article are handed over to you for taking further necessary legal action against him.
