During the outbreak of communal violence on 3rd May 2023, she had left her Bolero vehicle B/regmn No. MN01AW 7456 which was purchased on loan from SBI Main branch MG. Avenue under Account Number 471839 on January 2023 was parked at her rented house located at Porompat, Imphal east for safety measures while she was moved to a safer location.

Recently, on 8th October 2023 at about 10:00 am, when she was made an enquiry about her vehicle from one of her known person Mr Khangembam Nelson Singh @ Buka S/o Khangembam Budhamani Singh through telephonic contact number 7005665419 and 9862272341, 7085209129. She was informed that the said vehicle which was parked within the premises of her rented house is missing /not seen. Immediately verified the information and found that her vehicle had indeed been lost/stolen from the aid

In view of the above, thereby requested to kindly registered a case (FIR) regarding the missing /loss of her Bolero vehicle take up necessary investigation, and initiate legal action to trace and recover the vehicle and bring the culprits to justice as per law.
