Rajib Khan, In-Charge Cyber Lab, Imphal East District corroborated with our own intelligence about the presence of an active member of the outfit KCP Porompat Ayangpalli Raod, Imphal East District. Based on the said information and with the permission/authorization of the authority, a combined team of CDO/IE Unit, Cyber Lab, Imphal East Unit and a column of 33 AR conducted a C.I. Ops. at the said area under the command of Shri. Klumant Dhiraj Karan, MPS, Dy. SP(Ops)IE also looking after the charge of OC-CDO/IE Unit, supervised by Shri. Joyraj Singh, MPS Addl. SP(Ops)IE and under the overall supervision of Shri. Shivanand Sarma, Superintendent of Police Imphal East District.

In that, one unknown suspicious person was detained for spot verification at Porompat Ayangpalli Road near JNIMS main gate, Imphal East District. On spot verification, the detainee identified himself as one Huyam Rameshwor Singh @ Yaima @ Tayai (67 years) S/o (Late) Huyam Tombi Singh of Lalambung Takhellambam Leikai, Lamphel PS, Imphal West. On further verification, the detainee stated that he is an active member of the outfit KCP (TaibangNganba) group joined through one Mr. Kiran of KCP (Tabaing Nganba) group in the month of April, 2025 and presently working under the command of one s/s - Army Chief Mr. Taibang Nganba of KCP (Taibang Nganba) group. The detainee further stated that he was involved in the extortion of money from the general public for raising their party under the command of the said Mr. Taibang Nganba of KCP (Taibang Nganba) group.

So, the detainee was arrested from the spot i.e. Porompat Ayangpalli Road near JNIMS main gate, Imphal East District at 7:35 p.m. and seized one mobile phone (Realmi 95G) bearing IMEI no. 862907065164496/17 & 862907065164488/17 along with two SIM cards having no. BSNL 9402737443 & JIO - 8787578716 from his possession at the spot i.e. Porompat Ayangpalli Road near JNIMS main gate, Imphal East District at 7:40 p.m. by observing due formalities

Therefore, the arrested person along with the seized mobile phone is being handed over to you for taking up further necessary legal actions against him.


