Amit of KCP (PWG) in the month of July, 2023 and presently working under the command of the said Md. Amit of KCP (PWG) group. The detainee further stated that she had recruited three cadres to their outfit in the month of August, 2023 on the advice and instruction of the said Md. Amit of KCP (PWG) group. She further stated that she along with the said Md. Amit had handed over the said three recruits to one Mr. Ta Manao of KCP(PWG) group at Thanga Karang, Bishnupur District.

So, the detainee was arrested from the spot i.e. Hatta Golapati near Auto-rickshaw parking, Porompat PS, Imphal East District at 4:25 p.m. and seized one mobile phone (Redmi 13C 5G) bearing IMEI no. 868618071369961 & 868618071369979 along with one Airtel SIM card having phone no. 8131073082 at the spot i.e. Hatta Golapati near Auto-rickshaw parking, Porompat PS, Imphal East District at 4:30 p.m. by observing due formalities.

Therefore, the arrested person along with the seized mobile phone is being handed over to you for taking up burther necessary legal actions against her.
