Sir,

I have the honour to report that today i.e., the 31st October, 2025 at about 3:00 p.m. received a reliable information from our own source about the presence of a woman active member of the outfit KCP, who were involved in recruiting cadres of their outfit at Hatta Golapati area of Imphal East District. Based on the said information and with the permission/authorization of the authority, a combined team of CDO/IE Unit and 31 AR along with woman police personnel of Imphal East District police conducted a searched operation at the said area under the command of Shri. Khumanthem Dhiraj Karan, MPS, Dy. SP(Ops)IE also looking after the charge of OC CDO/IE Unit, supervised by Shri. Y. Joyraj Singh, MPS Addl. SP(Ops)IE and under the overall supervision of Shri. Shivanand Surve, IPS, Superintendent of Police Imphal East District at 4:30 p.m.

In that, one unknown suspicious woman was detained for spot verification at Hatta Golapati near Auto-rickshaw parking, Imphal East District. On spot verification, the detainee identified herself as one **Mrs. Anar Begum, aged about 60 years, W/o Md. Hesamuddin of Kwakta Bazar Ward no. 7, Moirang PS, Bishnupur District, A/p - Hatta Golapati near KR Lane Porompat PS, Imphal East District.** One mobile phone was found and recovered from her possession.

On further verification, the detainee stated that she is an active member of the outfit KCP (PWG) group joined through one Md. Amit of KCP (PWG) in the month of July, 2023 and presently working under the command of the said Md. Amit of KCP (PWG) group. The detainee further stated that she had recruited three cadres to their outfit in the month of August, 2023 on the advice and instruction of the said Md. Amit of KCP (PWG) group. She further stated that she along with the said Md. Amit had handed over the said three recruits to one Mr. Ta Manao of KCP(PWG) group at Thanga Karang, Bishnupur District.

So, the detainee was arrested from the spot i.e. Hatta Golapati near Auto-rickshaw parking, Porompat PS, Imphal East District at 4:25 p.m. and seized **one mobile phone (Redmi 13C 5G) bearing IMEI no. 868618071369961 & 868618071369979 along with one Airtel SIM card having phone no. 8131073082** at the spot i.e. Hatta Golapati near Auto-rickshaw parking, Porompat PS, Imphal East District at 4:30 p.m. by observing due formalities.

Therefore, the arrested person along with the seized mobile phone is being handed over to you for taking up further necessary legal actions against her.
