The detainee further disclosed that he had handed over; **one .303 rifle, two nos. of INSAS rifles, three nos. of SLR, two nos. of Carbine and one AK rifle** which were looted/snatched from various police stations/Security personnel to one Mr. Irengba @ Romen and one Mr. Khaba of RPF/PLA, who are on the Wanted List of NIA (National Investigation Agency). On further verification, the detainee disclosed the under noted names of the DRO (District Revenue Officer) of their outfit RPF/PLA who are being funded to their outfit RPF/PLA by extorting money from various district, departments and agencies are;

- v) Education Department: S/S Lt. Col. Sanajoaba from Andro Mamang Leikai, Imphal East.
- vi) Social Welfare Department: S/S Lt. Col. Nonghou @ Ibomcha from Kwakeithel, Imphal West.
- vii) Project Section: S/S Major Nongpoknganba from Thongju, Imphal East and
- viii) Goods Tax Department: S/S Major Khelemba from Jiribam and S/S Lieutenant Colonel Mr. Jibon from Bashikhong, Imphal East.
