Respected Sir, Recived a report vide SP ENDST NO C-5/8/SP-IE/2025/11940 dated 8th august 2025 complaint by one namely Miss Syed Reshma w/o Md. Shahbuddin of Hatta Complaint against 1. Mrs. Singamayum Majida, 2. Md. Altaf, 3. Md. Musadar, and 4. Md. Hamid for cheating and selling a stolen vehicle (Hyundai CRETA, Regd. No. MN01 AS 3161) regarding a ase of cheating and the fraudulent sale of a stolen vehicle stating that in Aug 2021, from Porompat crossing, Imphal East, she our chased a Hyundai CRETA vehicle bearing Registration No. MN01 AS 3181 from Md. Altaf and Md. Musadar, both residents of Yairipok Phouden, for a total amount of Rs. 9,40,000/-. At the time of purchase, the vehicle was registered in the name of Mrs. Singamayum Majida, W/o Rafi Ahamed, of Yairipok Ningthounai, Mayai Leikal, Imphal East. When she requested the necessary documents for transferring the vehicle to my name, Md. Musadar and one Md. Abash of Thoubal Moijing handed me a Xerox copy of an Aadhaar card in the name of Mrs. Singamayum Majida at Hatta. Md. Musadar and Md. Altaf further convinced me that the vehicle was genuine by stating that Md. Hamid-who they introduced as their boss-was working in the Police Department, and that the registered owner, Mrs. Majida, was their sister and serving in the 9th IRB. They said the vehicle was being sold due to financial difficulties. Based on these representations, I proceeded to transfer the vehicle to my name. wever, a few days later, she was informed by the Hyundai service centre that the vehicle had been reported as stolen. Upon earning this, I contacted them through Md. Hamid, who then invited me to his residence at Yairipok Singa on 30th April 2023. There, Md. Hamid promised-on their behalf-to return the vehicle and refund me Rs. 7,80,000/- within one were Regrettably, till date, neither the amount has been refunded nor the vehicle returned. Despite my repeated efforts to contact them, they have consistently ignored her calls and messages. Hence the report.
