3. One Scorpio Vehicle (white in colour) bearing Registration No. AS12K-6496, Chassis No. MA1TA2MWND2G27127 and Engine No. MWD4G10419.

Sir,

I have the honour to state that today, i.e. 09/11/2025, at around 01:15 a.m., a team of the Special Task Force Unit, Imphal East District, conducted random mobile frisking and checking at JNIMS Crossing, Porompat, under the command of Insp. Rajib, in-charge STF-Unit IE Dist., under the supervision of Shri Ak. Sadananda Singh, MPS, Addl. SP(Traffic)/IE, who is also looking after the charge of Addl. SP(Ops)IE and under the overall guidance of Shri Shivanand Surve, IPS, Superintendent of Police Imphal East District.

During the frisking and checking, one vehicle coming from the southern side towards JNIMS Crossing was stopped and detained for verification. On verification, it was found that two occupants were inside the vehicle i.e. one driver and one co-driver.

As per lawful procedure, we identified ourselves as police personnel of Imphal East District to them. The person in the driver's seat identified himself as Md. Salman Khan (35 years), S/o (L) Bashirman of Ward No. 8, Kwakta Khuman, Moirang, Bishnupur District and the other identified himself as Md. Sahidur (51 years), S/o (L) Md. Amu of Ward No. 2, Bishnupur District.

During the verification, both of them behaved uncomfortable and suspicious manner. Accordingly, checked the vehicle and one black-coloured polythene carry bag and found contained suspected illegal substances in the carry bag. Upon questioning, Md. Salman Khan disclosed that the bag contained medicines which he was supposed to deliver to one Mr. Jahar, aged about 35 years, who was waiting for him at Motbung.

Accordingly, the detention process was videographed, and both the individuals, along with the vehicle, were brought to the STF Office, Porompat, for further verification.

They were informed of their right to be searched in the presence of a Gazetted Officer or Executive Magistrate, and upon their consent, a thorough search was conducted in the presence of a Gazetted Officer, namely Shri. Khumanthem Dhiraj Karan, MPS, Dy. SP(Ops)IE, who was also looking after the charge of OC-CDO/IE Unit and the witnesses.

During the search, the black polythene carry bag was found to be containing a substance suspected to be WY tablets. In the presence of the Gazetted Officer and witnesses, weighing was conducted using a weighing scale and found that the weight of all the sachets was 2.3 kilograms (approx.), including polythene sachets in total. The total value of the seized contraband in the international market, as per the Narcotics Control Bureau (NCB) Notification dated 24/10/2025, is approximately Rupees One crore and eighty-four lakhs (Rs. 1,84,00,000/-).

In the presence of the Gazetted Officer and the witnesses, from the possession of Md. Salman Khan (35 years), the following items were seized at 12:55 pm on 09/11/2025.
