While conducting frisking and checking two suspected unknown women are coming from Andro side towards Yairipok with a Honda Activa 6G without bearing regd. No., red in colour are detained for verification and checking at 4:00 pm. on verification they identified themselves as (1) Usham Pakpi Devi (47) yrs. W/o (L) Usham Inaocha Singh of Samaram Maning Laibung, Kang Samaram, P.O- Wangjing, P.S- Khongjom, Thoubal district & (2) Leihaorongbam Premi Devi (39) yrs. W/o (L) Leihaorongbam Premchandra Singh of Charangpat Mayai Leikai, Charangpat Maklang, P.O- Thoubal, P.S- Thoubal, Thoubal district. On further checking by the lady constable found 15 (fifteen) nos. of demand letters in the name of unlawful organization PREPAK from the possession of Leihaorongbam Premi Devi along with one MI mobile phone and found one Narzo 50 mobile phone from the possession of Usham Pakpi Devi. Further, they disclosed that, they are active cadre of banned unlawful organization PREPAK and working presently under the command of Angousana (R/O) Finance Secretary PREPAK, and extortion money from general public for raising fund of the party. Further they disclosed that, today they were served a demand letter to Mrs. Sagolsem Sama Devi (52) yrs. D/o (L) S. Madhop Singh of Andro Chembra, Mamang Leikai, P.O- Yairipok, PS- Andro, Imphal East district. So, they are arrested from the spot at 4:40 pm & 4:42 pm respectively and seized the two mobile phone, one Honda Activa 6G and 15 (fifteen) nos. of demand letter of PREPAK at 4:50 pm and 4:55 pm respectively by observing necessary formalities. Hence the case.

Further they disclosed that, today they were served a demand letter to Mrs. Sagolsem Sama Devi (52) yrs. D/o (L) S. Madhop Singh of Andro Chambra, Mamang Leikai, P.O- Yairipok, PS- Andro, Imphal East district. So, the detainees are arrested from the spot i.e Naka point of forest beat office gate, Ngariyan foothill at 4:40 pm & 4:42 pm respectively and seized the two mobile phone 1) NARZO-50 bearing IMEI no. 860496050550853/34 & 86049605050846/34 along with one SIM card having mobile no. 9366570279 two SIM cards having mobile no. Airtel-9233658529 and Jio- 9366882759 and MI 903F11I bearing IMEI no. 867482040519714 & 867482040519722 along with two SIM cards having mobile no. Airtel- 9233658529 and Jio- 9366882759 2) One Honda Activa 6G, red in colour without registration no. 3) 15 (fifteen) nos. of demand letters of PREPAK 4) Two sling bag, maroon colour and black colour at 4:50 pm and 4:55 pm respectively by observing necessary formalities.

Therefore, the arrested persons and the seize articles are being handed over to you for taking up further necessary legal procedures.


