Mrs. Samjhana Thapa, Wife of Srikant Gupta and Daughter of Man Bahadur Thapa, resident of Aranoday Gorkha Samaj, Bhagilram Jote, Budhkaran, P.O. & P.S. Naxalbari, Dist.: Dariceling, West Bengal, Pin: 734429 would like to state that:

That I married to one Srikant Gupta as on 22.07.2017 at Mantripukhri, Marcy Lane, Manipur, Pin: 795002. It was an inter-caste marriage. That since the inception of my instance my in-laws namely a) Sangeeta Gupta (mother-in-law), b) Sri. Santaji Gupta (brether-in-law), c) Jyoti Gupta (sister-in-law) on the absence of my husband they have subjected me to regular mental and physical torture. That they frequently hurled abusive and obscene language at me and constantly threatened me with dire consequences, including pouring petrol on me and setting me on fire, in an attempt to force me to leave the matrimonial home. That their behaviour caused me severe fear, trauma, and mental agony. They were completely opposed to our marriage due to it being inter-caste. That although my husband made several attempts to mediate and protect our marital relationship, their behaviour remained unchanged and continued unabated.

- That I believed over time the situation would improve and my in-laws would eventually accept our marriage. However, ever since the birth of my daughter, their hostility worsened. They expressed clear dissatisfaction and started pressuring me to give up my child to an orphanage. They repeatedly told me that if I refused to do so, they would forcibly take her away and abandon her themselves.
- That due to my firm refusal to surrender my daughter, my in-laws escalated their abuse and involved additional individuals to intimidate and assault me physically and mentally. They salled upon a) Neha Dutta, Wife of Santaji Gupta, b) Nobin Dutta, Son of Nupur Dutta, c) Ankush Dutta, Son of Nupur Dutta, c) Mother-in-law of Santaji Gupta and f) Anjana dutta (wife of Vikrain paul). That in recent times, they have collectively started threatening me with demands for ₹50,00,000/- (Rupees Fifty Lakhs only) in cash and 100 tola of gold as downy. They made it explicitly clear that unless these demands were fulfilled, they would not the abuse and torture would continue until my death and reiterated their intent to forsely separate me from my daughter and send her to an orphanage, as they do not consider either this as part of their family.

That as on 05.07.2025, during the absence of my husband, I was driven out of my furthermonial home along with my daughter by the in-laws, who also threatened that if I

On 05/07/25 during the absence of her husband, she was driven out trom her matrimonial house when her husband intervenes, they also threatened her husband as well looking this situation she came back to her parental house.

Over this written complaint as occurrence of offence does not falls under our P.S. Jurisdiction, started case no. ZERO/25, Dated 13/07/2025, U/S- 85/351(3) of BNS & r/w section 0.4 of Downy Prohibition Act.

Under the above noted fact and circumstances you are requested to kindly send the ZERO FIR to the concerned Superintendent of Police, Imphal East, Manipur P.S. for Investigation of the case.
