It is most respectfully requested that, on dt. 07/8/25 at @ 04:00pm, the complainant namely Sarangthem Inakhunbi Leikai aged about 49yrs W/O (L) S. Woman Meitei of Chingnungkok Mayai Leikai, I/E submitted a report to OC/WPS. It stating that on dt.04/8/25 at @ 5: 10 pm, her daughter namely Sarangthem and/or 24yrs had consumed poisoned (jungle cutting) and vomit. Then, she was brought to JNIMS hospital and admitted in Bed no. 12, Medicine Ward in serious condition. When she enquired to her daughter about the reason for consuming poison, she stated that she was raped by the person namely Saikhom Tondon @ Ton 24yrs S/O S. Sanjoy of Changangel Maning Leikai and abandoned. Hence the case was registered under FIR NO. 31(8)2025 WPS/IE for investigation.

During the course of investigation, it is learned that the victim woman was under medical treatment at Medicine Ward, Bed No.12-A, JNIMS. However, her health condition is serious and could not able to record her statement thoroughly.

It is kindly requested that the concerned doctor be directed to record the statement of the victim, who is currently undergoing medical treatment in the Medicine Ward, once her health condition becomes stable. This will greatly assist in the progress of the investigation.


