9. My husband has a history of drug and substance abuse. Although he is currently running a rehabilitation centre for drug users, he himself has a bad track record of substance dependence.

10. He is also a sexually perverted person, who constantly maintains relations with other girls for fulfilling his sexual needs, which has caused me immense mental cruelty, humiliation and trauma within my marital life.

11. The cruelty continued even after I gave birth to my baby daughter. On 7th March 2025, immediately after the first feeding ceremony (Chak-umba) of my baby, unable to bear further physical assaults, sexual violence, threats and mental harassment, I returned to my parental home for safety.

12. I was not able to file my complaint in time as I was under trauma and was anxious as to what it will bring to my marital relationship between me and my husband but now when I am with my parents now only I could gather enough courage and strength to file this complaint.

In view of the above, I humbly request you to kindly register an FIR against my husband and mother-in-law under the appropriate provisions of the law and take immediate and strict action against them. I am ready to cooperate fully in the investigation and provide all evidence including Whatsapp screenshots, photographs of my injuries, medical prescriptions and witnesses to support my complaint.

Porompat, Imphal East District, Manipur

Facts of the Case :

1. That I was married to my husband on **29th December 2023** according to Manipuri Hindu customary rites and rituals.
2. That within three days of my marriage, my mother-in-law instructed me not to conceive a child for one year stating that it would be inauspicious. When I narrated this to my husband, instead of supporting me, he suspected my character and accused me of wanting to have boyfriends.
3. On the **5th day of our marriage**, after the Mangani Chakouba (traditional feast hosted by my family), my husband physically assaulted me at night by beating me. From that day onwards, I became a victim of regular physical torture and cruelty at the hands of my husband and mother-in-law.
4. In **March 2024**, I came to know that I was pregnant. Instead of caring for me, my husband and mother-in-law subjected me to further harassment, cruelty and beatings. **I was admitted and treated at RIMS Hospital after one such incident of physical assault. However, since my mother-in-law accompanied me to the hospital, I could not disclose the truth to the doctors and was forced to state that I had fallen by myself. I have photographs showing injuries from the assaults. [Photographs Enclosed]**
5. During my pregnancy, I was **denied medical expenses and daily needs**. Despite my critical conditions and complications (frequent bleeding), my husband and mother-in-law continued their harassment.





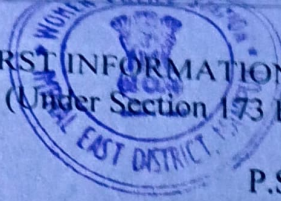
