Paonam Indira Devi pulled my hair and fallen me on ground, thereafter she repeatedly kicked me on my face and neck, and the others punched and kicked me in my chest and abdomen. Despite my cries for help, the assault continued until I lost consciousness.

When I regained consciousness, I found myself on a sofa, with the door left open. Taking the opportunity, I fled from the house of Indira Devi to save my life.

I immediately went to Heingang PHC, where doctors, after initial examination, referred me to RIMS/JNIMS due to the seriousness of my injuries. At JNIMS Hospital, I underwent diagnostic procedures including X-rays of the head and neck. Doctors also advised a CT scan, but due to ongoing threats and stalking by Indira Devi, I have been unable to leave my home safely for further treatment.


