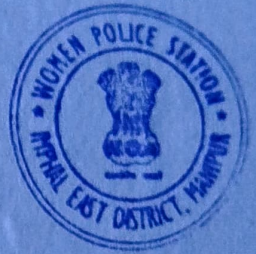



Siramani Singh of Ningthoukhong Ward No. 5, P.O. and P.S. Bishnupur, Bishnupur District, Manipur, as introduced by one of my friends. At that time, Thokchom Sidarth was undergoing training at NDA.

On August 10, 2025, we met and spent the day together. However, around 9 P.M., he dropped me at Moirangkhom Bridge, saying "Leihwro Yum Changlo," to which I replied, "Ei Ngamloi Ngna Chellani Haiduna Unaraga." Despite his words, he left me, driving away on his Activa scooter.

After some time, my mother called me, stating that Sidarth had informed her, "Nachanupidu Leihwrabani lwsinbiyu," and had also sent a photograph via WhatsApp, saying "Sida Leihourabani, Sigera Changera."

Around 10 P.M. that day, Sidarth called me and said, "Louba Laklage leiramu." I waited alone for him until 11 P.M. After that, Sidarth, along with his uncle, aunt, and sister's husband, came and said, "Yumda Thinbirage." I then called my aunt and narrated the events of the day. A conversation followed between Sidarth's aunt and my aunt over the phone. Finally, I was taken to the quarter of Sidarth's uncle located within the compound of JNIMS, Porompat and forcibly he sexually assaulted there on 11/08/2025 at @ 12.40 pm by promising that he will marry me.

Sidarth cohabited with me there. On the morning of 11th August 2025, Sidarth's elders visited my house for "Pao Haidokpa" as per custom, and later, I was brought to my house by Sidarth's family as "Nupi Thinba."

After a few days, Sidarth began distancing himself from me by not answering my calls.

From reliable sources, I came to know that Sidarth was having love affairs with other girls.

Such acts by Sidarth induced me to consent to cohabitation under a false promise of marriage, followed by elopement and performance of Meitei customs such as "Pao Haidokpa" and "Nupi Thinba." He later avoided marrying me and engaged in relationships with other girls, which severely




