Devan Singh of Koirengei Urum Mapal a/p Matai Mamang Leikai, Imphal East is suffering from mental condition called Dementia and she is on prescribed medication.

That, on 27/10/2025 at around 3:00 am, my mother was not found sleeping in her bedroom hence, we immediately, after informing our family members, started looking for her at our locality. While searching, at around 3:30 am, we found her being encircled by group of people including Yengkhom Sunita Devi and Nongthombam Bala Devi, both from Luwangsangbam, at a place at Luwangsangbam near Liberal College main gate. Initially, some injury marks could be seen on her person at the place due to physical assault. She was then rescued and taken to our house. Later, her health condition deteriorated and upon further checking, we found that she had been beaten black and blue and her person was fully covered with injury marks. She was rushed to hospital for medical treatment.

In the light of above facts and circumstances leading to her subjection to physical and mental torture without any known reason, I request you to kindly initiate legal action against the miscreants.

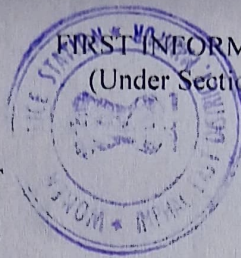
