Received a report from Shemkholal Haokip, Chairman, S.Kholui, K Songlung Part-II that on behalf of the Village Authority lodge a formal complaint regarding a serious act of vandalism that occurred in their village. The incident took place on the night of 11th September 2025 at the village farm areas, village roadside, entry gate. The damage was discovered on 12th September 2025

The following village properties were intentionally damaged:

- Village Name Signboard-A rectangular board along with its post where the name of the village is written was dismantled into pieces.
- Farm Signboard-A farm signage with the word "S KHOLUI FARM" for information and identification.
- Notice Board-Forest Department authorised notice, prohibition of hunting and protection of wildlife, avifauna and fishing was shredded.
- Gate-An entry gate which is usually kept closed and only open upon authorisation which is used to prevent trespassing has been demolished.

This was a deliberate act of mischief aimed at causing harm to the community and not only causes inconveniences to the residents and visitors alike but may also cause further issues to arise regarding territorial disputes and local etiquette between different communities and neighbouring villages.

Therefore, he kindly request that you register this complaint as a First Information Report (FIR) and take the necessary steps to investigate the matter, identify the culprits, and initiate legal proceeding against them. They are willing to cooperate fully with your investigation and provide any further information required. Thank you for your prompt attention to this urgent matter.



I, Shemkholal Haokip Chairman, am writing on behalf of the Village Authority to lodge a formal complaint regarding a serious act of vandalism that occurred in our village. The following village properties were intentionally damaged:
