T.Michael Lamjathang Haokip, General Secretary, Thadou Inpi Manipur (TIM) reported that the Thadou Inpi Manipur (TIM), the apex body representing the Thadou people, respectfully submits this complaint to draw your kind attention to grave incidents of coercive monetary collection and harassment being carried out against Thadou villagers by certain Kuki militant organisations and village authorities in Motbung and K. Phoipi Villages, both of which are Thadou villages under Saitu-Gamphaol Sub-Division, Kangpokpi District, Manipur. On the evening of 11th October, 2025, around 7:00 p.m., the Motbung Village Authority announced through a Public Address System that every household must contribute Rs. 2,000/- per head to repay Motbung Thadou Baptist Church for funds allegedly used to purchase weapons during the Manipur Violence 2023, reportedly donated to the Kuki National Front (KNF). However, the Thadou People's Declaration, 2025, adopted on 13th September, 2025, at Thadou Veng (Gaon), Diphu, Karbi Anglong, Assam, solemnly declares: "No Thadou individual or household, in any region, shall henceforth make any payment in the form of tax, levy, or donation to any Kuki individual, organisation, or militant group." This Declaration explicitly prohibits any form of payment, direct or indirect, to Kuki militant organisations, reaffirming the Thadou people's commitment to peace, truth, and their distinct ethnic identity. Furthermore, on the morning of 9th October, 2025, the Kuki Revolutionary Front (KRF), a Suspension of Operations (SoO) signatory organisation under the United Peoples Front (UPF) with the Government of India and the Government of Manipur, reportedly instructed the K. Phoipi Village Authority that all government employees, both armed and unarmed, must contribute Rs. 4,000/- per head. Following negotiation, the amount was reduced to Rs. 1,500/- per head. Such coercive and unlawful monetary demands by SoO signatory organisations and local authorities grossly violate the ground rules of the Suspension of Operations Agreement, constitute extortion and intimidation, and endanger public peace, the rule of law, and citizens' safety. It is deeply concerning that Thadou villages such as Motbung and K. Phoipi, peaceful communities committed to lawful living are being targeted, harassed, and coerced into making payments to armed or affiliated Kuki groups. These acts directly violate the Thadou People's Declaration, 2025, and infringe upon the Fundamental Rights guaranteed under Articles 14, 19, and 21 of the Constitution of India. In the light of the above, the Thadou Inpi Manipur earnestly requests your esteemed offices to:Order an immediate and impartial investigation into the incidents at Motbung and K. Phoipi Villages by registering an FIR against the KNF and KRF outfits without any delay. Take firm legal and administrative action against the Motbung Village Authority, K. Phoipi Village Authority, and both KNF and KRF under UPF, a SoO signatory organisations with Govt. of India and Govt. of Manipur, involved in these unlawful acts. Ensure adequate protection for Thadou residents against coercion, intimidation, and extortion by any militant or affiliated group. Strictly enforce the Suspension of Operations ground rules and hold violators accountable. Safeguard the constitutional and fundamental rights of Thadou citizens to live peacefully, free from fear, coercion, and discrimination.


