That on 02nd November, 2025 at around 08:30 am as a part of drive against illicit poppy plant cultivation, a combined team of Kangpokpi District Police consisting of Shri Syed Samir Ahamad, MPS, ASP(OPS) Kangpokpi, G. Thaingampoi R.Naga, SDPO/NKM and his escort, OC NKM-PS and his escort, 2nd OC LMK-PS and his escort, one column (1-1-15) of 19 Assam Rifles, 2(two) platoon of 30 BN CRPF, 1(one) Platoon of 86th BN CRPF and a team of KCP-PS conducted an operation for destroying poppy plantation under the overall supervision of Shri Abhinnav, (IPS), SP-KPI at 2(two) poppy cultivated areas in Songlung Village and another in the bordering areas of Lhangjol and Waphong Inthan villages under the Jurisdiction of Kangchup PS located at South West from the PS itself. No individual found in the destructed areas. During the operation, the combined security forces succeeded in destroying 30 (thirty) acres of poppy crops cultivated land area in total approximately. 3 (three) nos. of poppy plants having its flower and fruit were plucked and seized from the spot. Plucked 3(three) poppy pod/flowering top as a representative samples which were put inside 3 (three) seperate brownish paper envelopes and marked as A'1 and A'2 as parent sample and duplicate sample and another 1(one) poppy pod/flowering top as a parent seizure also put inside a brownish paper envelop marked as "A" in presence of the representative sample envelopes. The paper envelopes were seal by using sealing wax. Accordingly at 09:30 am of the same day, I have seized the said 3(three) poppy pods by preparing a formal seizure

memo in presence of the witnesses. Then, the illicit opium/poppy plants were cut down/uprooted. The activities of destroying/cutting of poppy plants concluded at 03:55 pm. Photographs were taken for adducing evidence if required in the court of law.

Hence, it is requested to take up further necessary legal action(s) against the owners/relatives in the contraband illegal cultivation of poppy plantation throughout the hills of Songlung, Lhangjol and Waphong Inthan Villages.
