On 20th August, 2025 when they visit their residence then he came to know that all his household properties were ransacked, plundered and looted by unknown miscreants from nearby localities.

The total cost of properties lost, including all his household items, piggery farm and many other valuable properties is estimated to be about Rs. 50,00,000 and Land (paddy field) is estimated to be around Rs. 20,00,000/0. Hence the case.

Sir,

With due respect, I would like to state the following for your kind information for your kind information and necessary action:-

That, due to the on-going conflict, we were compelled to flee our home located at my land at Kangchup Chingkhong village, PO Lamsang, PS Gammon Sapormeina, Kangchup geljang Sub-division, Kangpokpi District, Manipur,

On the 3rd of may, 2023 around 9:00 PM.

Due to on-going conflict we were compelled to flee and settle at relief camp at Churachandpur district. On date 20 August, 2025. We visit our resident then we came to know that all my household properties were ransacked, plundered and looted by unknown miscreants from the nearby localities.

The total cost of properties lost, including all household items, piggery farm and many other valuable properties is estimated to be about Rs. 50,00,000 (Rupees fifty lakh) and Land (paddy field) estimated to be around Rs 20,00,000 (twenty lakh)

Reason of delay: Assuming that the properties in the house were there later when we visit the residence all the properties were stolen by unknown persons.

In this regard, I would like to request your good office to take up necessary action so that I can be compensated, the culprits be caught and stringent exemplary punishment meted upon them.
