I have the honour to state that today i.e 27/10/2025 @ 7:00 pm, while conducting a random frisking and checking along the NH-2 at T Khullen NAKA check point (under SPT-PS jurisdiction), Kangpokpi District, Manipur by Senapati Police Special Operation Team, Senapati, one passenger vehicle Tata Winger bearing Reg. No MNO4P-2567 was seen coming from Imphal side towards Senapati side. The said vehicle was stopped for frisking and checking. On enquiry, the driver of the vehicle is identified as Atawar Rahaman (32) yrs s/o Md. Abdul Sattar of Kshetri Awang Leikai, Imphal East, P.O & P.S – Porompat, Manipur. On checking the vehicle, suspected Ganja were found in the Trolley bags of the following persons viz (1) One Trolley bag (White and Blue in colour) belonging to Mohammad Shoaib Alam (22) yrs s/o Aziz Shah of K.R. Lane Golapati, P.O & P.S – Porompat, Imphal East District, (2) One Trolley bag (Dark Red in colour) belonging to Sunir Phundreimayum (21) yrs s/o Md. Sagir Ahamed of Lilong Haoreibi Mayai Leikai, P.O & P.S – Lilong, Thoubal District and (3) One Trolley bag (Dark blue in colour) belonging to Kh. Rafique (22) yrs s/o Md. Idrish Ali of Yairipok Bamon Leikai, P.O & P.S – Yairipok, Thoubal District. Following which, the three individuals were detained. As such DC/KPI was intimated and a request was made to depute one magistrate. Accordingly, SDC HQ/EM-KPI Shri. Lhunkhopao Touthang (Executive Magistrate) was deputed for doing the necessary procedures.

On arrival of the Executive Magistrate and in his presence and in the presence of the three individuals namely (1) Mohammad Shoaib Alam (22) yrs s/o Aziz Shah of K.R. Lane Golapati, P.O & P.S – Porompat, Imphal East District, (2) Sunir Phundreimayum (21) yrs s/o Md. Sagir Ahamed of Lilong Haoreibi Mayai Leikai, P.O & P.S – Lilong, Thoubal and (3) Kh. Rafique (22) yrs s/o Md. Idrish Ali of Yairipok Bamon Leikai, P.O & P.S – Yairipok, Thoubal District, the 3 (Three) Trolley bags were thoroughly checked. On checking the Trolley bags, 13 (Thirteen) packets of suspected Ganja weighing 4.298 kg along with plastic cover were found in one White and Blue Trolley bag which belongs to Mohammad Shoiab Alam, 2 (Two) packets of suspected Ganja weighing 2.400 Kg were found in One Dark Red Trolley bag belonging to Sunir Phundreimayum and 2(Two) packets of suspected Ganja weighing 2.378 Kg were found in one Dark Blue Trolley bag belonging to Kh. Rafique.

The 17(Seventeen) packages suspected to be Ganja were weighed by using weighing machine in the presence of the Executive Magistrate and witnesses and weighted 9.076 kgs (with plastic cover). The approximate value is Rs. 9, 076/- (Nine thousand seventy-six). The 17(Seventeen) packages of suspected Ganja were seized in the presence of the Executive Magistrate and witnesses by preparing a formal seizure. The detained person was formally arrested by observing formalities at 8:40 pm. During the seizure and arrest, videos or photos was not uploaded in eSakshya as I don't have an authorized eSakshya account. However, I have recorded the video of the seizure and arrest in the phone. No individual is willing to be an independent witness. Therefore, the arrest and seizure is made without independent witness.
