Sir,

With reference to the above cited subject, I the undersigned submit the following inquiry report.

That, on 31st July 2025 at around 2230 hrs received a reliable information that some unknown non-locals' individuals were operating a cyber crime racket to buy mule accounts.

A team led by the undersigned rushed to ISBT, Khuman Lampak and intercepted two unknowns non locals. Upon asking their identity they identified themselves as Bikram Basumatary aged 31 yrs S/o Mathur Chandra Basumatary of Balapara, District-Barpeta, P.S-Sorthebari, Assam and Sudem Basumatary aged 35 yrs S/o Manoj Basumatary of Balagari, District-Chirang, P.S-Angoori, Assam.

Both of them were detained and brought at Heingang PS for further verification. On preliminary enquiry they stated that they were assigned task to make data entry of unknown's transactions and collection of credentials data of individuals like bank account details, Aadhar card details etc. They were made to stay at a place near ISBT, Khuman Lampak to commit the fraudulent activities. During the enquiry, they could not provide proper registration documents of their firms or agency and it is highly suspected that they are running a cyber crime racket in the various places.

While checking their mobile phones it is also came to learnt that various unaccounted transactions were made for transfers of Rs.2,00,000/-,Rs.3,00,000/-,Rs.4,00,000/-,Rs.2,00,000/-,Rs.50,000/- and Rs.40,000/- totaling an amount of Rs.11,90,000/-(eleven lakh ninety thousand). On further checking their mobile phones numerous numbers of bank accounts details have been found. The bank accounts were further checked on the NCRP (National cybercrime reporting portal) and found that 2(two) numbers of bank accounts have been linked to economic offence complaint reported in the NCRP portal from different states.

Hence, cognizable offences have been meted out against the above noted persons.
