Subject: - Report.

Sir,

I have the honour to state that today i.e. 01/08/2025 at around 04:05 pm, a reliable information was received from our own source and further corroborated from the information input provided by 33 AR regarding the presence of some active members of KCP organization, an outlawed banned organization in and around Mantripukhri area of Imphal East District with a view to commit prejudicial activities like extortion of money from shops and general public etc. Based on the information, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri. P. Achouba Meetei, MPS, Dy.SP(CDO)IW and under the supervision of Shri. Gaurav Dogra, IPS, i/c Addl. SP(Ops.)IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Police Control Room and conducted search operation at some suspected places of Mantripukhri area. During that one suspected person was detained near Christ Jyoti School, Mantripukhri. On spot verification, the detainee identified himself as Yaikhom Moramba Singh (21 yrs.) s/o (L) Y. Samjai Singh of Khurai Heigrumakhong Konsam Leikai, Imphal East District.

During preliminary verification, he disclosed that he is an active member of KCP(MFL) organization (a faction of KCP organization) and presently working under the command of one s/s Commander Wilson (Ph. No. 8132064042) of KCP(MFL) organization from Serou who is presently staying in Myanmar. He also disclosed that he and his associate namely one Jebashish (Ph. Nos. 8132978838/7642005907) from Kwakeithel were involved in sharing contact numbers of doctors of valley area to his Commander Wilson for extortion activities.

He further disclosed that he was also involved in looting/snatching of arms and ammunitions from 7-MR, Khabeisoi in the year 2023 and he handed over 2 (two) nos. of SLR (which were looted/snatched from 7-MR) to the members of Ishing Thembi club (Yumnam Khunou side), Imphal East District.

Hence, he was arrested from the spot i.e., near Christ Jyoti School, Mantripukhri at 04:58 pm by observing necessary formalities.

From his possession, (i) one realme 9i 5G mobile handset along with two SIM cards i.e., (a) one Jio SIM card bearing mobile no. 9362332175 (as disclosed by him) and (b) one Airtel SIM card bearing mobile no. 8798136879 (as disclosed by him), (ii) one Aadhaar card bearing no. 5907 7334 9592 and (iii) one black side bag containing a sum of Rs. 10,000/- (Rupees ten thousand only) were seized at 05:06 pm by observing due formalities.

Hence, the arrested person and the seized articles are handed over to you for taking further necessary legal action against him.
