Sir.

I have the honour to report that today i.e. the 6<sup>th</sup> August, 2025 at about 11:00 a.m. received a credible information from our own source about the presence of some active members of the outfit KCP at Ahallup area of Imphal East District. Based on the said information, a combined teams of CDO/IE Unit and 4 AR under the command of Inspt. N. Devdas Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops)IE conducted a searched operation at Khurai Chairen Thong, Imphal East at about 12:00 noon.

In that, one unknown suspicious person was detained for spot verification and checking at Ahallup Lai Haraopham, Imphal East District. On checking the detainee body, one wallet was found and recovered from his possession. On verification, the detainee identified himself as one Ingudum Tularanjan Meitei @ Abung (29 years) S/o I. Ibosana Meitei of Taothong Mamang Leikai, Lamshang PS, Imphal West. On further verification, the detainee stated that he is an active member of the outfit KCP (PWG) group, joined through one Mr. Sanaton of KCP (PWG) in the month of June, 2024 and working under the command of one Mr. Mubi of KCP (PWG). The detainee further stated, on the advice of the said Mr. Mubi of KCP (PWG) he was involved in the kidnapping of one Doctor and kept hiding at a farm-house at Lamdeng Khunou for taking ransom money in the month of August, 2024.

So, the detainee was arrested from the spot i.e. Ahallup Lai Haraopham, near the main gate of the Lai Haraopham, Imphal East District at about 12:49 p.m. and seized one wallet containing a sum Rs. 80/- (eighty rupees) and one Voter ID card from his possession by observing due formalities at 12:54 p.m.

Therefore, the arrested person along with the seized items are being handed over to you for taking up further necessary legal actions against him.
