Subject: Report regarding arrest and seizure of suspected narcotic substance during routine frisking and checking duty.

Sir,

I have the honour to submit that on 27/10/2025 at about 07:00 pm, I, M. Rinas Meitei, ASI of ANTF (Anti-Narcotics Task Force, Imphal East) and my team, along with a team of Irilbung Police, were conducting routine frisking and checking duty at IVR, Kiyamei Takhok area, on the eastern side of Basikhong Bridge Road, as part of regular patrolling duty and as a preventive measure in view of the prevailing law and order situation in the state.

During the course of checking, two persons riding an Activa scooter (blue in colour) were seen coming from the western side of the bridge. Our team stopped them and instructed them to halt for verification. The two persons were identified as:

- i) Md. Ashif Ali (aged about 18 years), S/o Hasim, of Kiyamei Muslim Awang Leikai.
- ii) Md. Washim Khan (aged about 22 years), S/o (L) Hassan Bashir, of Kiyamei Muslim Takhok Makha.

On checking the vehicle and opening the toolbox, a black polythene packet was found concealed inside. Upon opening the packet, three plastic caps containing suspected No. 4 Heroin Powder were detected.

On preliminary questioning, Md. Washim Khan deposed that he had collected the said narcotic substance from one Md. Rohit @ Sahir (aged about 22 years), S/o (details not known), of Lilong Lou Manga area, for a sum of Rs. 27,000/- per cap containing suspected Heroin Powder No. 4. Further, Md. Ashif Ali deposed that the suspected psychotropic substances were meant for sale to his interested customers. The suspected psychotropic substance contained in Plastic Caps, along with the said vehicle bearing registration No. MN01AC/ 8892 and a Redmi 5G Mobile phone Handset, was seized on the spot at 07: 20 pm on production by Md. Washim Khan. The psychotropic substance contained in Plastic Caps, was properly packed, sealed, and labelled. Further, on production by Md. Ashif Ali an iPhone Mobile Handset, was also seized at 07:25 pm. Two respective seizure memos were prepared at the spot in the presence of witnesses. It is pertinent to note that no independent witnesses were available at the relevant location and time to witness the seizure. Accordingly, the accused persons were then arrested at 07:30 pm.

Hence, I am submitting herewith the seized materials along with the arrested persons for your kind information and necessary legal action as per law.
