Sir,

I have the honour to report that today i.e., the 27th October, 2025 at about 7:00 p.m. received a reliable information from our own source corroborated with the intelligence of 2/8 GR and 16 AR about the presence of some active members of the outfit RPF/PLA at Langdum village of Imphal East District. Based on the said information and with the permission/authorization of the authority, teams of CDO/IE Unit conducted a C.I. Operation at the said area under the command of Shri. Khumanthem Dhiraj Karan, MPS, Dy. SP(Ops)IE also looking after the charge of OC-CDO/IE Unit, supervised by Shri. Y. Joyraj Singh, MPS Addl. SP(Ops)IE and under the overall supervision of Shri. Shivanand Surve, IPS, Superintendent of Police Imphal East District at 8:00 p.m.

In that, one unknown suspicious person was detained for spot verification at a house at Langdum Awang Leikai, Imphal East District. On spot verification, the detainee identified himself as one Moirangthem Pakpa Meitei @ Athouba (43 years) S/o M. Muhindro Meitei of Langdum Awang Leikai, Irilbung PS, Imphal East District. On further verification, the detainee stated that he is an active cadre of the outfit RPF/PLA joined through one Mr. Dolen of RPF/PLA in the year 2000 and got his basic military training for 45 days at Sajik Tampak, Manipur with allotted army no. 3179 under the command of one s/s – Mr. Bobby. The detainee further stated that he is presently holding the rank of s/s - Private and working under the command of one Mr. Opendro of RPF/PLA.

On further examination, it came to learnt that he kept conceal two nos. of hand grenades at his house. On checking the detainee room, two nos. of No. 36 Hand Grenades along with two nos. of Igniters were found and recovered on the instance of the detainee. On further examinations, the detainee stated that the above recovered hand grenades were handed over to him by the said Mr. Opendro of RPF/PLA in the month of December, 2024.

So, the detainee was arrested from his residence i.e. Langdum Awang Leikai, Imphal East District at 8:48 p.m. and seized **2 (two) nos. of No. 36 Hand Grenade with two nos. of Igniters** from his possession at 8:55 p.m. at the spot i.e. Langdum Awang Leikai, Imphal East by observing due formalities.

Therefore, the arrested person along with the seized hand grenades are being handed over to you for taking up further necessary legal actions against him.
