Sir,

I have the honour to report that today i.e. the 28th October, 2025 at about 3:00 a.m. received a reliable information from our own source and with the intelligence input from 165 TA about the concealment of arms, ammunitions and explosive at Keirao Wangkhem village and its surrounding foothill area of Imphal-East District. Based on the said information and with the permission/authorization of the authority, a combined team of CDO/IE Unit, 165 TA and 7 MADRAS Regiment conducted a search operation at the said area and its surrounding foothill area of Imphal-East District under the command of Shri. Khumanthem Dhiraj Karan, MPS, Dy. SP(Ops)IE also looking after the charge of OC-CDO/IE Unit, supervised by Shri. Y. Joyraj Singh, MPS Addl. SP(Ops)IE and under the overall supervision of Shri. Shivanand Surve, IPS, Superintendent of Police Imphal East District at 400 a.m.

In that, one yellow sack bag containing the undernoted arms, ammunitions and explosives which were kept hiding at the foothill of Ngariyan hill, near TB Hospital Keirao Wangkhem Imphal East District were found and recovered.

- 2) 1(one) no. of 12 bore single barrel gun marked as '26013-09' with sling.
- 3) 1(one) no. of 12 bore single barrel gun with sling.
- 4) 1(one) no. of .32 Pistol marked as 'AUTO PISTOL CAL 7.65 A 77377' with magazine.
- 5) 2(two) nos. of No. 36 Hand Grenade without detonator.
- 6) 1(one) no. of 7.62 mm SLR live Ammunition.
- 7) 9(Nine) nos. of 7.62 mm AK live ammunition.
- 8) 2(two) nos. of 5.56 mm INSAS rifle magazine.
- 9) 5(Five) nos. of .303. live Ammunition.
- 10) 3(three) nos. of .303 Ammunition charger clip.
- 11) 1(one) no. of 51 Motar HE Shell and
- 12) 2(two) nos. of Tear Smoke Shell (CS).

Accordingly, the above recovered arms, ammunitions and explosives along with the sack bag which were suspected to keep conceal by unknown arms militants were seized at the spot i.e. foothill of Ngariyan hill, near TB Hospital Keirao Wangkhem, Imphal East District at 4:40 a.m. by observing due formalities.

Thereafter, the seized arms, ammunitions and explosives along with the sack bag are being handed over to you for taking up further necessary legal procedures.
