- 2. Background. Intelligence inputs received through HUMINT & TECHINT indicating the presence of UKNA (a non SoO Group) cadres in the general area Khanpi, Henglep Sub Division, approx 30 km North West of Churachandpur. The intelligence was corroborated by multiple sources, confirming that the insurgent group was using Khanpi village as a temporary base for their operations and training.
- 3. Conduct of the Operation.
- 3.1. On 29 October 25, a team of Security Forces was launched on foot from the general area Noney towards Khanpi with the aim of conducting covert surveillance and verifying the intelligence inputs.
- 3.2. On the night of 30/31 Oct 25, the team successfully reached general area Khanpi and established surveillance base, which confirmed the presence of UKNA cadres in general area Khanpi village.
- 3.3. Simultaneously, on night of 30/31 Oct 25, another column of 36 Assam Rifles ex COB S Khollen was launched from the south towards Henglep. This column also established a surveillance base and observed the presence of UKNA cadres in Henglep village.
- Both Khanpi and Henglep were kept under discreet surveillance, and a coordinated operation was launched 4 planned · to be first at light 01 Nov 25. However, at approx 1900 hour on 31 Oct 25, the presence of security forces was detected by the insurgents group in both the villages. Soon after, info received that the UKNA cadres had fled into the surrounding jungle areas. Seizing the opportunity, both the Security Forces team/ columns launched ops to apprehend the fleeing cadres. Despite their efforts, the insurgents managed to escape under cover of darkness, inclement weather, and dense vegetation.
- 3.5. Following this, an overt movement of 36 Assam Rifles was deliberately conducted in Henglep and Khanpi to create an impression of full de-induction of security forces. The column carried out search operation in the villages in broad daylight and de-inducted overtly to reinforce the de-induction.



- 3.6. The overt de-induction of 36 Assam Rifles column was later picked up by the UKNA cadres, and TECHINT intercepts confirmed that the cadres had assessed the area to be clear of security presence and were planning to return to Khanpi.
- 3.7. On the night of 03 Nov 25, the Security Forces team detected UKNA cadres again into Khanpi village. The team covertly approached using hours of darkness and successfully cordoned off the suspected hideout in the night.
- 3.8. At approx 0530 hour on 04 Nov 25, the Security Forces challenged the UKNA cadres to surrender using loud hailer. However, the UKNA cadres opened heavy and indiscriminate automatic fire. The Security Forces retaliated with controlled and precise fire, simultaneously giving opportunity to surrender by communicating through loud hailer.
- 3.9. Despite repeated warnings, the cadres continued to engage with sustained automatic fire, resulting in two security forces personnel sustaining gunshot wounds. When efforts to persuade the cadres to surrender failed, the security forces carried out a deliberate assault on the hideout with precision and controlled fire.
- 4. In the ensuing fire fight, four UKNA cadres were neutralised, and a substantial quantity of arms and war-like stores were recovered.

- 7. Operational Significance. This operation is of high tactical and strategic significance as it follow spate of violent incidents perpetrated by UKNA, which includes the killing of a Khonomphai village chief


