Sir,

I have the honour to report that today i.e. 14/10/2025 at 1:00 pm, while conducting random frisking and checking by a joint team of Mao-PS, SOT-Senapati District, 02/01/20 a column from BNHQ, 16 AR. 01/01/20 and a column from B-Coy, 16 AR at Mao check gate along NH-2 which is about 1 km North West of Mao-PS. During frisking and checking one Tata Yodha bearing Regd. No. NL07AA-3011 coming from Senapati side towards Dimapur was stopped by the team for checking.

While checking the vehicle, the driver was found in a suspicious manner, on interrogation he admitted to possess illegal drugs. On confirming the presence of soap cases suspected to be brown sugar, ADM/MAO was intimated and a



request was made for authorizing for carrying out formalities. Accordingly Shri Panii Ngaonii, SDC/SPT was deputed as Executive Magistrate. On his arrival, two persons identified themselves as (1) H. Linii (35) yrs S/o Ch. Hriipou of Tungam Afii, PO-Tadubi PS-Tungjoy Senapati District, Manipur (driver) A/P TNK Senapati, PO/PS- Senapati and (2) V. Mado (36) yrs S/o Vihrii of Tunggam Afii Village, PO-Tadubi, PS-Tungjoy A/P TNK Senapati, PO/PS-Senapati. On checking, 30(thirty) soap cases of suspected brown sugar were recovered concealing inside the right side of front bumper. The 30 (thirty) soap cases suspected to be brown sugar were weighed in presence of executive Magistrate and witnesses by using weighing machine with video coverage as per BNSS in presence of the Executive Magistrate. The consignment was found to be weighing 407 grams including the weight of plastic packets (excluding the weight of soap cases cover). Further, the following items were also recovered from his possession:-


