FIRST INFORMATION REPORT

- 1. Based on a specific input of Contraband being carried in a veh. an OP was launched at 1600 Hrs by troops ex COB Behiang. Three indls have been nabbed who were carrying 10Kgs 780 gms raw opium inside scooty boot. 10 Kgs 780 gms opium (Latex of poppy) worth ₹ 54 lakhs were found inside 2x Scooties. Subsequently the column ex COB Behiang apprehended the individuals at 1630 Hrs.
