Sir,

I have the honour to report that today i.e. 22/10/2025 at 6:00 pm, while conducting random frisking and checking by a team of Mao-PS, at Martyrs Park along NH-2 which is about 2 km South of Mao-PS. During frisking and checking one Taxi Alto-K10 bearing Regd. No. NL01TA-1035 yellow black in colour coming from Senapati side towards Dimapur with passenger was stopped by the team for checking.

While checking the vehicle, one passenger was found in a suspicious manner, on interrogation he admitted to possess illegal drugs. On confirming the presence of soap cases suspected to be brown sugar, ADM/MAO was intimated and a request was made for authorizing for carrying out formalities. Accordingly ADM/MAO Shri. Rang David Kung (Executive Magistrate), Song Song. On his arrival, one person identified himself as Mohd. Khomei (54) S/o (L) Md. Hayad Ali of Paobitek Maning Leikai, PO/PS- Wangoi, Imphal West District, Manipur. On checking, 9 (Nine) soap cases of suspected brown sugar were recovered concealed inside his carry bag. The 9 (Nine) soap cases suspected to be brown sugar were weighed in presence of executive Magistrate and witnesses by using weighing machine with video coverage as per BNSS in presence of the Executive Magistrate.
