Sir,

- 1. It is submitted that in continuation of operation Songot and following the successful apprehension of selfstyled Lt. Jamkhogin Lupho along with five cadres of the UKNA (Non-SoO group) earlier this month, further actionable intelligence has been developed regarding the presence of another active UKNA cadre clandestinely operating within Churachandpur town. The apprehension of their senior leader had dealt a major blow to the outfits operational network as well as financial backbone, however, remnants of the group have been making desperate attempts to reassert their presence and regain their cont in the town. Reliable sources indicated thet the UKNA leadership, currently operating from undisclosed hideouts in Churachandpur, has directed its local operatives to rebuild organizational strength, mobilize new recruits for trg and generate funds for proc of wpns through systematic extortion drive. Intelligence further suggests that the group is in contact with arm suppliers across the border and its planning to acquire weapons to rearm its cadres in anticipation of future confrontations.
- 2. The groups heightened activity has manisfested in a series of coordinated extortion demands targeting educational institutions, government employess and commercial est in the Tuibong area, aiming to instill fear and project their continues relevances. Recent incidents of threats and monetary demands reported across the town further substantiated the suspected presence of their cadre. The devp indicated renewed attempts by UKNA remnants to regroup, re-establish their influence and raise operational funds through coercive means posing a significant threat to the ongoing peace and stability in the reason. Mr Haominthang Haokip was also involved in serving extortion notice & collection of funds from the town area.
- 3. Acting on the latest intelligence, an operation was launched by 36 Assam Rifles with a strength of 00-01 -20 at 2330 hours on 23 October 2025 under Sub SK Jha and apprehended the suspect from the general area of Old Gelmuol, Churachandpur, at 0245 Hrs on 24 Oct 2025. The apprehended individual has been identified as Haominthang Haokip (18 years), son of Lunkhohao Haoip, resident of Old Gelmoul, Churachandpur, Manipu.
