Respected Sir/ Madam,

I, Md. Belal, being duly authorized representative of Pace Digitek Limited, a company incorporated and registered under the Companies Act, 1956, having its Circle office at Babupara, BSNL, Imphal, Imphal west District, Manipur, would like to inform you on behalf of the Company that we have a mobile tower installed at Village -Haiphai, P.S- Chakpikarong, District - Chandel, Manipur (SITE I.D. -UVN2MNP00840/ Site Name- Haiphai).

That, on 21-09-2025 at 10:00 am when I visited our mobile tower site for day-to-day maintenance work, I discovered that 1(One) **DG battery**, amounting to Rs. 9000/- (Rupees Nine thousands_only), has been stolen from the said site. Upon enquiry it is understood that the theft appears to have been committed by some miscreants/ unknown persons, which has caused a financial loss to our company and disrupted network connectivity in the area.

Accordingly, the incident was intimated to the Circle Office and then we verified the value of materials stolen from the records maintain in our Corporate Office and thus there is no intentional delay or lashes on our part in filing the instant Complaint.

We were searching the stolen battery with the help of Village authority. As such & couldn't report well in time.
