12. First Information contents:

Received a report from Kamginlen Chongloi S/O (L) Ngulneilal Chongloi of Leilon Phaikot village, Kangpokpi District, Manipur, Consuancy Staff, Stn Hqtrs, Leimakhong that on 2<sup>nd</sup> October 2025 at around 1:30 P.M on his way back home from Saparmeina village, he was stopped and kidnapped by three unknown miscreants of Manipuri speaking at Makhan Village, Kangpokpi District near Indira Gandhi National Tribal University.

He was taken to secluded place at Khurkhul Village, Imphal West in White Gypsy, where his eyes were tightly covered with cloth, and he was brutally beaten and forced to give a wrong statement claiming he belonged to SOO group of KNF cadre and involved in Meitei house torching during the ongoing ethnic conflict. After physical assaulted and tortured, he was forced to walk barefoot and was later handed over to two subsequent vehicles. His eye covering was removed when he was being taken towards Sekmai, and he realized the vehicle belonged to Sekmai Police, which took him to Kangpokpi Police Station by exchanging at Kanglatongbi near Mandir.

Following medical attention at District Hospital, Senapati and an interrogation by Officer-in-charge Kangpokpi Police Station, he was handed over to his family on Date – 3<sup>rd</sup> October, 2025. Hence a case under FIR No. 24(10)2025 G SPM PS U/S 140(3)/117(2)/120(2)/61(2)(a) BNS has been registered for investigation.

With due respect, I, the undersigned, would like to bring to your attention a matter that requires an immediate and necessary action please, Yesterday i.e 2<sup>nd</sup> October 2025 at around 1:30 P.M on my way back home from Saparmeina village, I was stopped and kidnapped by three unknown miscreants of Manipuri speaking at Makhan Village, Kangpokpi District near Indira Gandhi National Tribal University.

I was taken to secluded place at Khurkhul Village, Imphal West in White Gypsy, where my eyes were tightly covered with cloth, and I was brutally beaten and forced to give a wrong statement claiming I belonged to **SOO group of KNF cadre** and involved in Meitei house torching during the ongoing ethnic conflict. After physical assaulted and tortured, I was forced to walk barefoot and was later handed over to two subsequent vehicles. My eye covering was removed when I was being taken towards Sekmai, and I realized the vehicle belonged to Sekmai Police, which took me to Kangpokpi Police Station by exchanging at Kanglatongbi near Mandir.

Following medical attention at District Hospital, Senapati and an interrogation by Officer - in - charge Kangpokpi Police Station, I was handed over to my family on Date - 3<sup>rd</sup> October, 2025.

I therefore request you to **registered FIR** and take an immediate and prompt action against the culprits involved in this incident and ensure justice is served.
