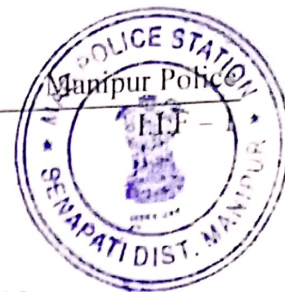

With due respect, I have the honour to report that today i.e. 12/06/2025 @ 4:30 pm, while conducting random frisking and checking by joint operation team of Mao-PS Police Team along with A/109, B/109 QAT & G/112 Bn. of CRPF and B Coy, 16 AR Mao, at Mao Gate Police check post about @ 1 km North-West of Mao-PS, one passenger Winger (white colour) bearing Regd. No. MN02G 1247 was seen coming from Imphal side towards Nagaland along NH-2. The said vehicle was stopped by the joint team for frisking and checking. While checking, 2(two) transparent plastic packets containing suspected to be Heroin powder were found concealed inside one Camouflage Air Bag of the passenger. On enquiry the owner was established and identified himself as one Anshu Raj (27) yrs s/o Raj Prasad of Purani Police Line, M.P Bagh Ara, PO Arrah, PS- Town Thana, District Bhojpur, Bihar. ADM/MAO was intimated and a request was made for authorizing for carrying out formalities. Accordingly ADM/MAO Shri. Rang David Kung (Executive Magistrate), Song Song himself arrived for doing the necessary procedures. The bag was checked in the presence of Shri. 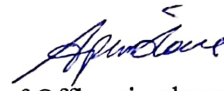
